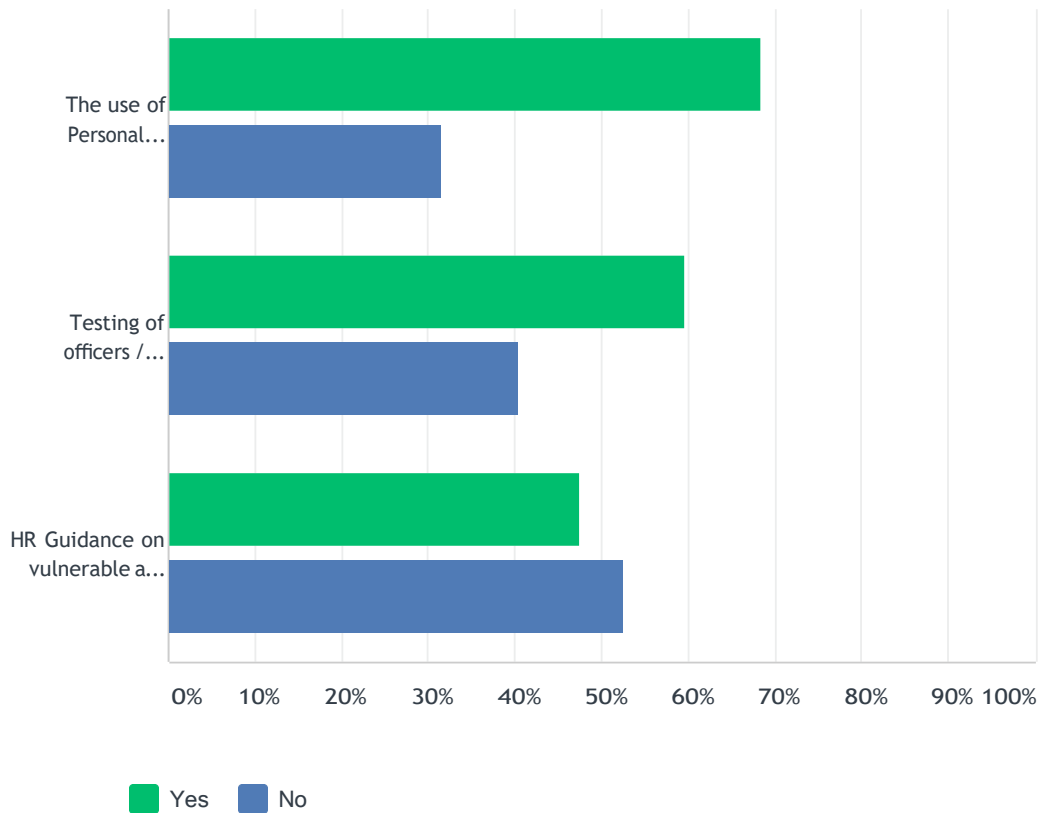


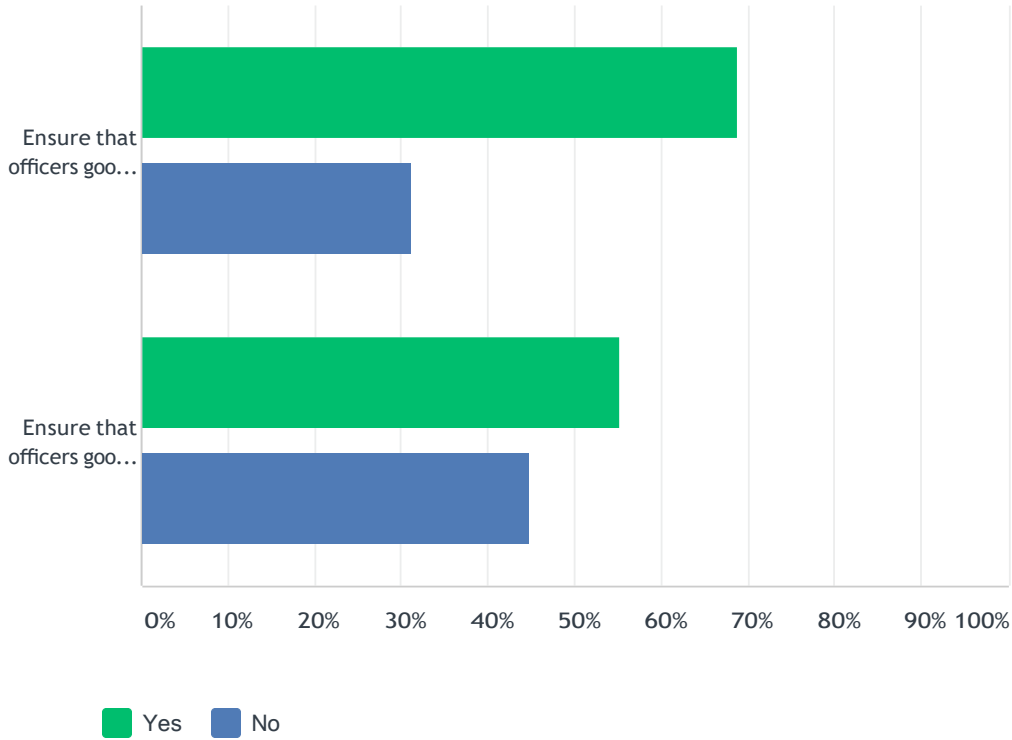


Q1 In recent weeks the agency has provided information and guidance on its response to the COVID-19 situation. Do you consider this guidance to be clear in relation to:



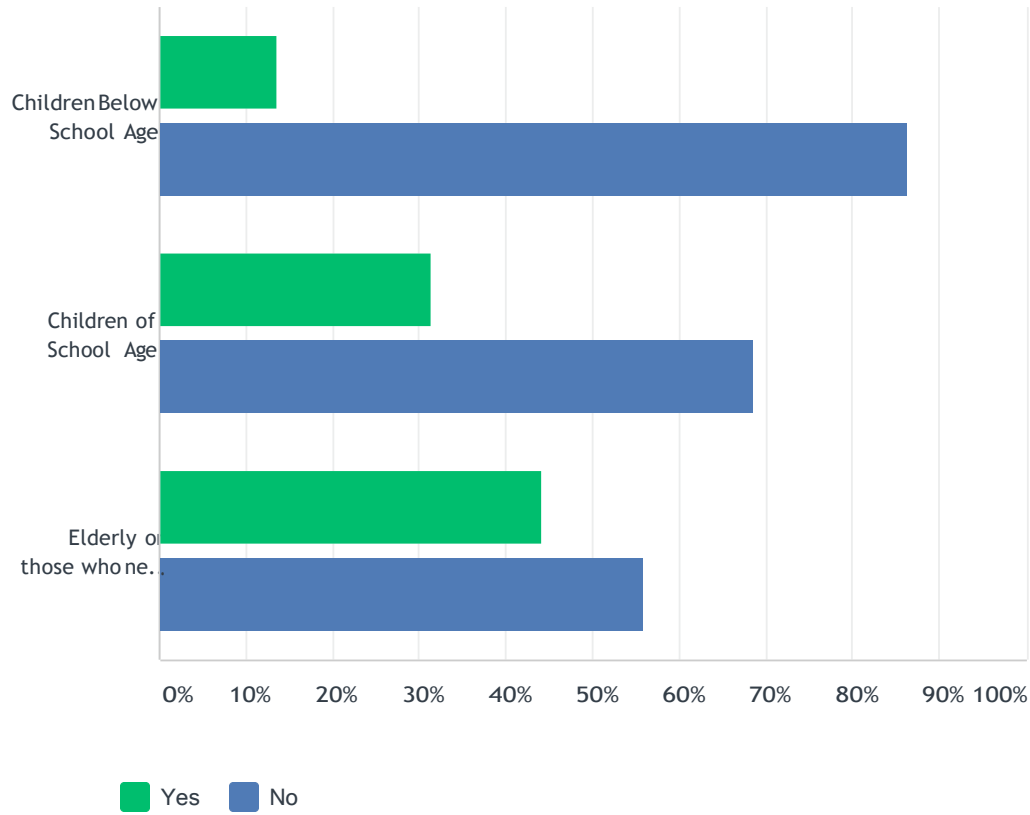

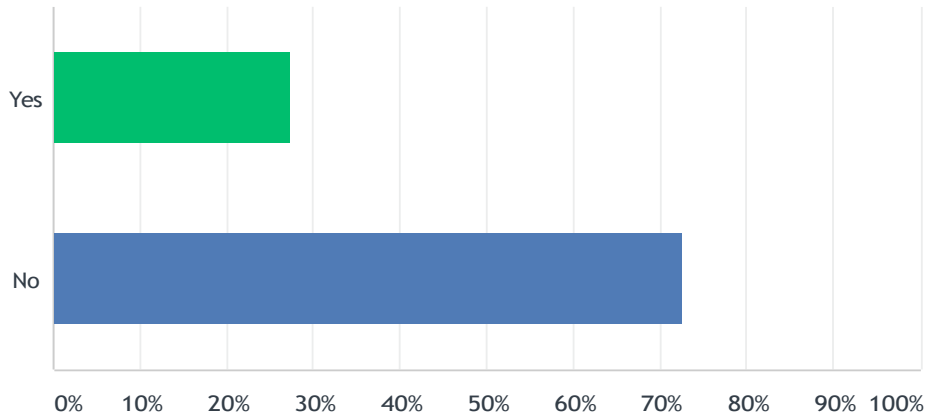

Q3 During the COVID-19 situation do you have increased caring responsibilities for:



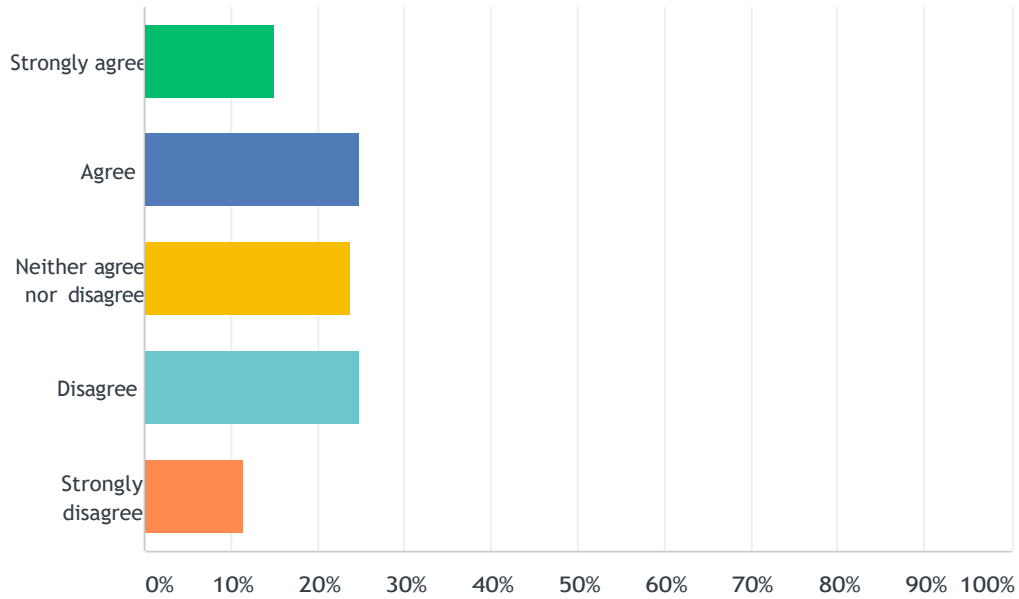

Q4 Has the Agency asked you directly whether you have increased caring responsibilities at this time?



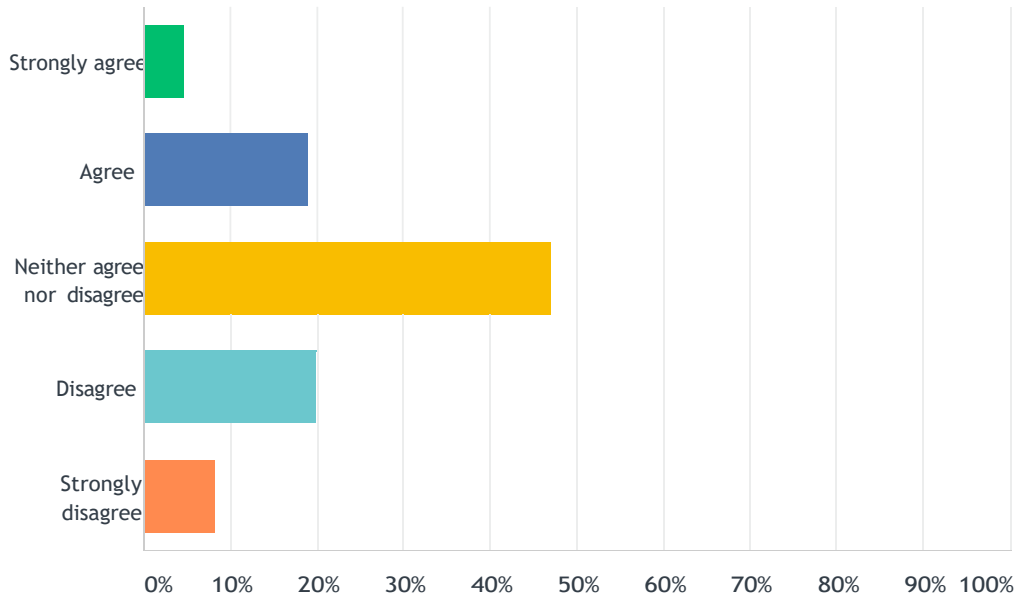

Q5 In relation to the National response to COVID-19, do you feel that your current domestic situation is affecting your work?



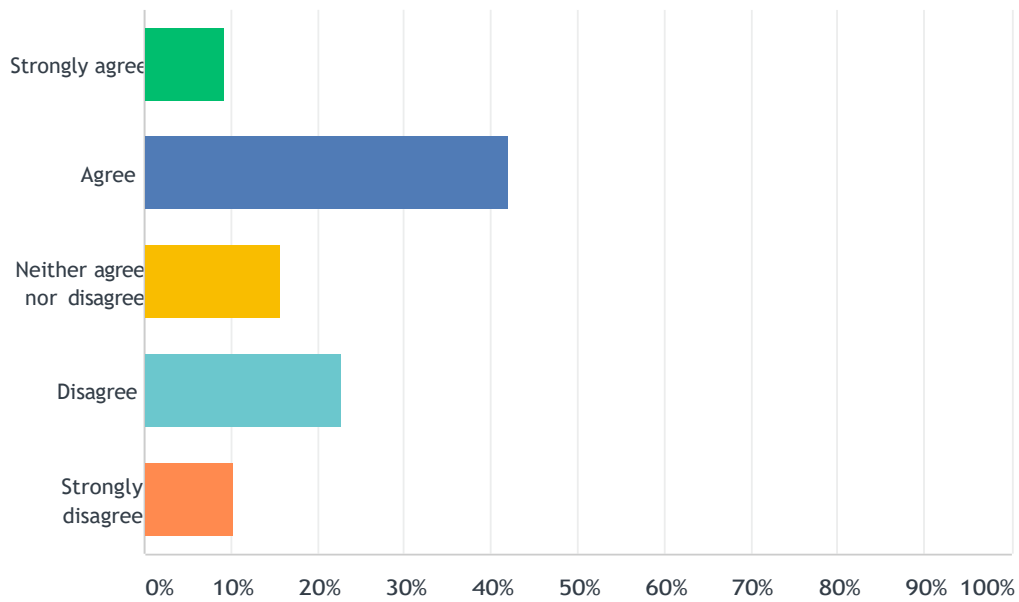

Q6 If your domestic situation is impacted, is this reflected in the Agency's expectations of you as an employee at this time?



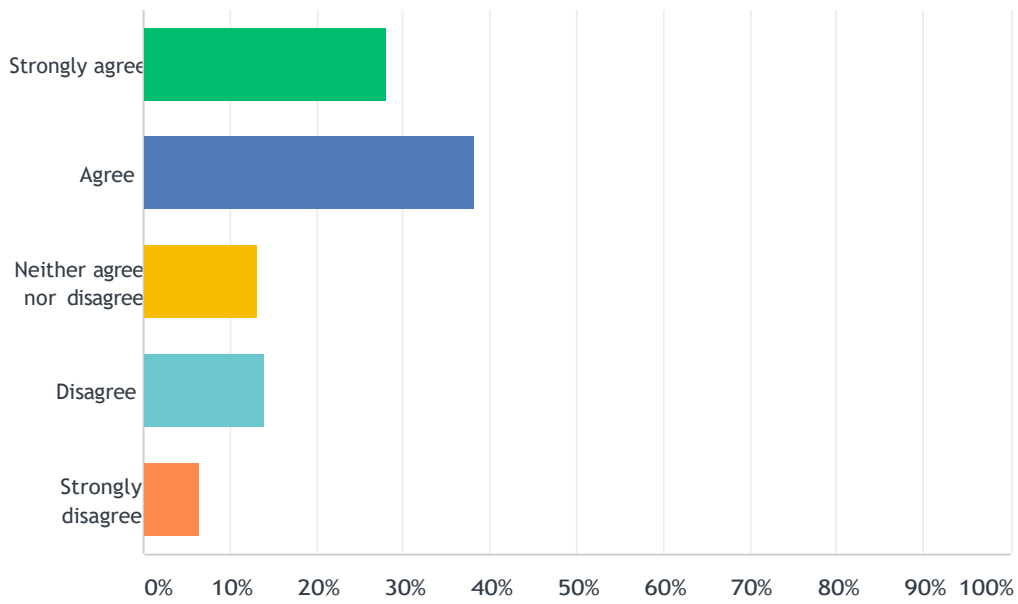

Q7 Do you feel the Agency has realistic expectations of you and your work output currently?



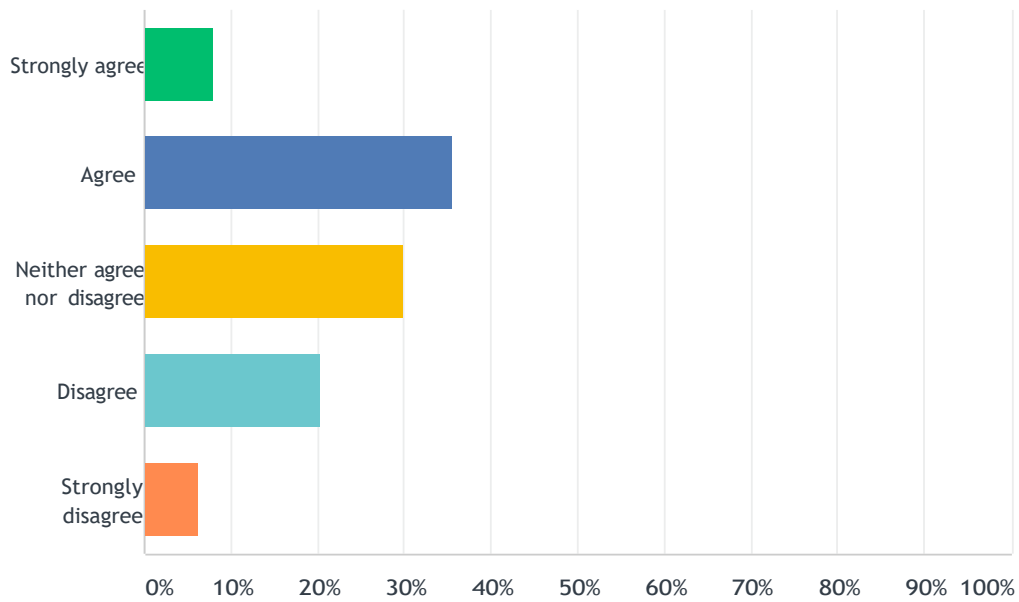

Q8 Do you feel that your local management team are providing you with sufficient support at this time?



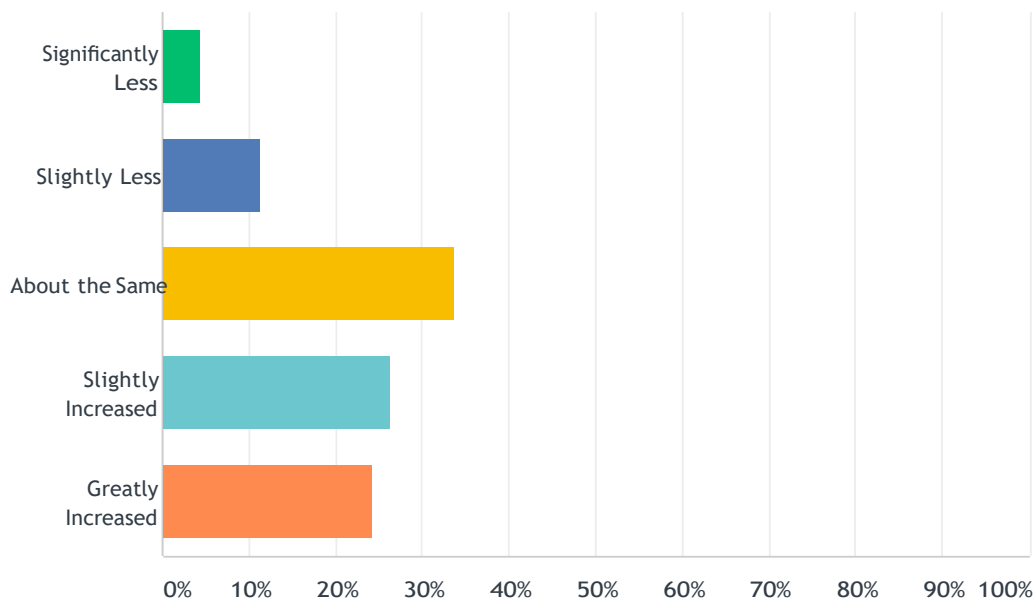
